SETTLEMENT AGREEMENT

(c) Defendant also agrees to sign a Confession of Judgment for the amount of \$1,582.79, plus the costs and disbursements of this action in the amount of \$80.00 and the costs of filing the Confession of Judgment, if necessary, in the amount of \$13.30. In the event that Defendant fails to comply with the terms set forth in paragraph (b) above, this Confession of Judgment may be filed for record with the Clerk of Court.



In the event the Confession of Judgment is filed for record, Plaintiff agrees to give credit for any payments already made pursuant to this Settlement Agreement.
